FY 2022-23 Budget Provides Funding to Meet Growth Demands

THE GARNER TOWN COUNCIL on June 21 unanimously approved a \$49,451,070 operating budget for fiscal year 2022-23, which runs from July 1, 2022, to June 30, 2023. The FY 2022-23 budget is a 14.4 percent increase over the previous year's budget and includes a property tax rate increase of four cents, bringing Garner's tax rate to 55.21 cents per \$100 of valuation. The four-cent increase on Garner's tax rate equates to

an additional \$93.50 annually for property valued at the average in Garner.

The FY 2022-23 budget will enable the hiring and training of 15 firefighters to staff the new Fire Station 5 on Caddy Road in the fast-growing U.S. 401/Ten Ten Road area of southwest Garner. It also

will allow the Town to make other investments in public safety, including life safety equipment and fire inspections staffing.

In future fiscal years, two cents of the tax rate increase will be dedicated to debt service on the \$69 million in streets and sidewalks bonds, parks and recreational bonds, public safety and facilities bonds (which will partially fund Fire Station 5) and stormwater bonds that Garner voters overwhelmingly approved in the 2021 municipal election. In their educational outreach, Town officials shared with voters that approval of the bonds would likely result in a two-cent rate increase in FY 2022-23.

Among the challenges the Town faced in balancing this fiscal year's budget is the delay—which can be

up to four years—between when services start to be provided for a development project and when the completed project generates tax revenue for the Town. The budget also was impacted by broader economic factors such as the increase in fuel and commodities costs.

Another fiscal challenge is that Garner's property valuations are considerably lower than those in several other Wake County municipalities, resulting in comparatively less revenue per penny on the tax rate.

Despite the tax rate increase, Garner still has the lowest effective tax and fees burden among Wake County municipalities (see chart). As in the past, the FY 2022-23 budget includes no separate fees for solid waste service or stormwater infrastructure. Costs for those are rolled into property taxes.
