It shall be unlawful for any person to organize, conduct or participate in any picket line or group demonstration in or upon any street, sidewalk, or alley or other public place within the Town of Garner unless a permit therefore has been issued by the Chief of Police or his designee.

The undersigned certifies that the activity will not require excessive diversion of police from other necessary duties, the activity will not interfere with the right of property owners in the area to enjoy peaceful and lawful occupancy and use of their property, the activity can be conducted without unreasonable interference with normal pedestrian or vehicular traffic in the area, the activity will not prevent normal police and fire protection to the public, and the activity will not be likely to cause injury to persons or property or to provoke disorderly conduct or create a public disturbance.

No permit shall be issued when the activity or purpose stated in this application would violate any ordinance of the Town of Garner or statute of the State of North Carolina, or when the activity or purpose would constitute a clear and present danger to the public health or safety or would hinder or prevent the orderly movement of pedestrian or vehicular traffic on the streets, alleys or sidewalks.

The undersigned has reviewed and agrees to abide by the provisions of Chapter 15, Article VII of the Code of Ordinances of the Town of Garner and understands that the Chief of Police or his designee shall revoke any permit issued upon the violation, by any participant in the group demonstration/picket line, of Chapter 15, Article VII of the Code of Ordinances of the Town of Garner or upon failure to comply with the terms and conditions of the permit.
