

Owner Plumbing Permit Affidavit

The state of North Carolina allows you to personally do your own Plumbing work in your own home provided you personally will reside in the home and that it is not for rent or intended for sale within one year after you complete the Plumbing installation. All Plumbing installations, changes, additions, or modifications to HVAC systems are subject to permitting and inspections.

PLEASE NOTE:

This exemption is for you personally to perform the Plumbing work yourself. (YOU CANNOT GET A PERMIT FOR SOMEONE ELSE TO DO THE WORK FOR YOU)

You must be the legal owner as recorded on Wake County tax records and reside in the property yourself (permanent residence) Attach Tax record cards for <u>all properties owned</u>.

Can an owner be denied a homeowner's permit? Yes

The Department may deny the issuance of Plumbing permits to, homeowners under any one of the following circumstances:

- There is reason to believe the proposed Plumbing work will be done by someone other than the owner.
- There is reason to believe the property is or will be sold on the completion of the Plumbing work.
- There is a reputable presumption that the property is or will be sold on the completion of the Plumbing work if the applicant, within the prior five years, has sold his or her home and the Plumbing work for said home was performed by the applicant under a homeowner's permit
- Previous homeowner Plumbing permits have not been completed in compliance with the code.
- The owner is temporarily residing in the home and it is **not the home on record or tax cards for all vehicles and personal property.**
- If the homeowner is found to have at any time violated or falsified any of the above items, they shall immediately cease all Plumbing work, forfeit the homeowner's permit, and obtain a licensed Plumbing contractor to complete the work in compliance with the job.
